I fully understand and acknowledge that (a) risks and dangers exists in my use of Paintball equipment and my participation in Paintball activities; (b) my participation in such activities and / or use of such equipment may result in my injury or illness including but not limited to body injury , disease strains, fractures, partial and /or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of MAM Paintball and Wellston Gun Club; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; (d) by my participation in these activities and /or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and /or damages, whether caused in whole or in part by the negligence of other conduct of the owners, agents, officers, and employees of MAM Paintball and Wellston Gun Club., or by any other person.
